## Opposing Industrial Park Expansion East Towards Sunny Slope Road

Dear Conservancy, High Grove, Hales Heights, High Point, Karrington Woods, Kelly Point, Sanctuary, and Woodfield Park Neighbor:

The proposed amendment to expand the business park/Industrial land use in Section 35, the agricultural land west of Sunny Slope Road, will have a negative impact on your neighborhood.

## Reasons to oppose the proposed amendment:

- 1. Property values will decrease.
- 2. The proposed residential barrier will likely only be multi-family units. The small barrier would not accommodate single family homes.
- 3. There is the possibility that the business park/industrial area could expand to Sunny Slope Road.
- 4. Noise, safety, traffic, and water issues.
- 5. Close proximity of the elementary school safety issue.
- 6. These issues adversely impact quality of life.

In true political form they can persuade other council members to vote yes while they vote no.
